CORRESPONDANCE

1. **Assembly Council report** – Nov 21-23 – from the moderator of presbytery, who is a member of the AC.

Assembly Council

November 21-23

The Assembly Council met from November 21-23 in a hybrid format that had some members joining by video conference and others attending the meeting in person at national offices of the PCC in Toronto.

The meeting opened with worship prepared and led by Carol Stymiest, who represents the Atlantic Mission Society at Council meetings and Cathy Reid, who represents the Women's Missionary Society. It was acknowledged that The Presbyterian Church in Canada and its members live, worship and work on this historic territory of the First Nations, Métis and Inuit Peoples of this land. As a church, we take seriously the challenge of reconciliation, to deepen bonds of friendship and solidarity, to strive to "Walk together" in the present and future and to live with integrity the words of Our Confession to Indigenous Peoples from 1994.

The Council expressed a strong preference for the next General Assembly (June 5-8, 2022) to be in person

and held at Wilfrid Laurier University. That is where the last two in-person Assemblies met. The General Assembly Office is working with the university to determine, by mid-January, if it will be able to host the Assembly. If the university cannot commit to hosting by mid-January, Assembly Council will reconvene to consider other options.

The courts, agencies, colleges, and camps of the church are to review and update their policies, procedures and practices this year to ensure they reflect the full inclusion of all people. The Assembly Council has completed the review of its own policies.

Representatives of the theological colleges, the Atlantic Mission Society and the Women's Missionary Society are members of the Assembly Council. During the meeting, the Council heard updates from representatives about the ministries of these bodies in the church.

The Council heard updates from the following Assembly Council working groups:

- The Council provided input to the working group that is preparing a response to overtures that seek a way for congregations to leave the denomination and ask for an alternative form of governance to be developed. The working group, comprising Peter Kinch, Barb Sargent, Linda Shaw, John-Peter Smit, Henry Han, Brenda Butler, Jeffrey Murray (with the Clerks of Assembly) presented a framework for its work, and noted that it has so far met twice. Members of the working group have been reviewing the Clerk's response from 2018, the report of Assembly Council's Gracious Dismissal Committee, and all the relevant overtures. Council met in breakout rooms and groups twice during the meeting and discussed the committee's interim work in plenary. The working group reiterated its desire to have a final report ready for Council at the March meeting.
- Work continues on the referral about Gender pay equity and discrimination
- A response to an overture requesting legal indemnity for those who exercise liberty of conscience related to remits B and C, 2019 is in process and will be considered at the March meeting
- Council approved a response regarding the Legal implications of the remits about ordination and marriage
- A working group presented a response to an overture requesting that the church establish a national registry of congregations and ministers that are willing to celebrate same-sex weddings. The response to the overture proposes that such a registry be created and maintained by the General Assembly Office. Participation in the registry would be voluntary and the information would be made available on the PCC website and through other appropriate avenues. The final report will be submitted to the General Assembly in 2022.

Understanding that the adoption of the remits about marriage and ordination presents both an opportunity and a challenge for the PCC to explore the Bible's vision of God's welcome of diversity, the Assembly Council engaged in a workshop called "How will we live together? led by The Rev. Dr. Pat

Dutcher-Walls. All the texts that were studied show a situation in ancient Israel or the early church where the household of God were asked to live together with a diversity of identities and a diversity of theological understandings (Joshua 9:1-27, Ruth 1: 1-22, 2 Kings 5:1-19, Mark 1:40-45, Mark 5:24-34, Mathew 15:21-28, Acts 8:26-39 and Acts 10:1-48). The Council considered the following questions based on what they read in the texts:

- God is a god who...
- The household of God valued diversity by...
- Congregations today can draw an analogy to this story to understand diversity in the household of God as...

The Rev. Dr. Pat Dutcher-Walls also spoke on behalf of the General Assembly Design Team. She noted that the team will study the summary of commissioner evaluations of the 2021 Assembly and she invited feedback on how the team could better support commissioners prepare for and participate effectively at future Assemblies.

The Council welcomed Marilyn Repchuck and Ian Mason from the Presbyterian Church Heritage Centre to give an update on the Centre's work.

Healing and Reconciliation is an important part of the Council's focus. The Council heard an update on some of the work being done in the church in this regard. Information about the church's work in this area can be found at https://presbyterian.ca/justice/social-action/indigenous-justice/. Staff of the Life and Mission Agency will attend a future meeting to update the Council on the church's response to the Calls to Action from the Truth and Reconciliation Commission. During the meeting, the Council approved terms of reference for the Honouring the Children: Reconciliation and Residential Schools Fund. This fund will support initiatives associated with searches for unmarked burial sites in communities where schools were operated by The Presbyterian Church in Canada.

The Council provided funds to support psychotherapy/counselling for those who have experienced harm done by homophobia, hypocrisy, transphobia and heterosexism in the denomination.

Barb Summers, the Associate Secretary for the Communications department of the PCC, will resign from her position at the end of February 2022. Fortunately, Barb will remain the editor of Presbyterian Connection newspaper. The Council approved a process by which the next Associate Secretary for Communications will be appointed and expressed thanks for Barb's extraordinary work for the church.

The Rev. Jinsook Khang and The Rev. Cherie Inksetter were named to the Assembly Council Executive.

The Principal Clerk position description was modified to include responsibility for representing the church in initiative supporting relationships with Indigenous peoples.

Closing worship was led by The Rev. Dr. Ross Lockhart, the Dean of St. Andrew's Hall at The University of British Columbia.

- Marilyn Repchuck, of the Presbyterian Church Heritage Centre, confirms her plan to speak at the April meeting of presbytery. Host church to facilitate a powerpoint presentation.
- 3. **New Beginnings Renewal Program**, in regard to an application from Paulin Memorial.

Your congregation has begun the New Beginnings process and the assessor to your church, the Rev. Mavis Currie has compiled initial reports regarding your congregation and community. It is recognized that Paulin Memorial Presbyterian Church has good potential for growth and ministry in south Windsor. Your sanctuary and facility are well cared for and you have a strong history of reaching out to your neighbours.

In conversations with Canadian Ministries, the assessor and the Hope Network for Missional Transformation staff, however, we are not confident that this is the right time for Paulin to be considering a process of transformation. It is clear that the pandemic has created many challenges for the congregation and with rising Covid 19 case counts over the winter months, we think it will be difficult for small groups to meet to discuss future stories for the congregation. In addition, it became clear during the assessment that Paulin Memorial has been navigating several conflicts over the last three years. A process of transformation and new beginning is better suited to a time when the congregation is in a place of stability

Paulin Memorial is encouraged to take the next six months to focus on intentional pastoral care and healing. If the Session would prefer the registration fee to be reimbursed until the process can be re-engaged, please let me know. I will check in with the Session in June and together we will discuss next steps.

This amount is past due and must be paid as soon as possible.

We are writing to you in your authority and responsibility as Presbytery to ensure that this money is paid in full. A notice has already been sent directly to the congregation's treasurer advising of the outstanding amount.

When Pension Plan congregational assessments are in arrears, The Presbyterian Church in Canada is deemed to be in "non compliance" with its Pension Plan regulatory requirements. There are serious consequences that the entire Church faces as a result of unpaid Congregational Assessments, therefore we kindly ask for your cooperation and immediate attention in resolving this matter.

Under Ontario pension legislation all contributions due to the plan must be remitted *monthly*.

We kindly request the Presbytery's assistance in verifying that all congregations submit their pension plan payments on time as required.

Concern was expressed by Rev. Tim Reddish who sat as a Clergy Commissioner for the 2021 Assembly, stating time restraints were a major concern for that meeting. It had been suggested that the 2022 Assembly be extended by one additional day.

MEMBERS OF ASSEMBLY COUNCIL

At the Presbytery of Essex/Kent meeting on February 15, 2022, a motion was passed instructing the Moderator to send a letter to Assembly Council expressing our concerns of having another online assembly in June of 2022.

As Moderator, I am forwarding these concerns to you. These concerns were discussed at the meeting.

- After the last General Assembly 2021 held online, a number of participants, congregations and presbyteries expressed concerns about a future online General Assembly. We feel that Assembly Council has not listened and given the concerns proper consideration. Assembly Council is not considering a number of issues and concerns affecting the denomination and the participants at another online GA.
- 2. If travel is still a concern, although things have opened up a lot in the past few weeks, Assembly Council should consider a Fall AG. This was not really discussed fully at the meeting. There are church venues that could accommodate the AG if held in the Fall in the Greater Toronto area.
- 3. In choosing to go ahead with another online GA, AC deeply prejudices the PCC against the ethnic Presbyteries and congregations with English as a second language. An online Assembly privileges those who speak English well and dis-enfranchises those for whom English is a second, or additional language. The rigid time limits advantage those who have expertise in English; and, as witnessed at the 2021 Assembly the tight time limits

- 4. dis-enfranchise those speaking by translation. As well, last year, a professional accredited translator was not employed by the Assembly for the Korean delegates.
- 5. GA is a place where people meet and form relationships and friendships. An in-person GA allows issues to be discussed outside the physical meeting and Commissioners are able to make more informed decisions as a result. They are able to listen to others in an informal way rather than a formal meeting.
- 6. This GA, in June 2022 will be dealing with petitions from the HanCa presbyteries regarding systemic racism. Other very important issues of Gracious Dismissal, Alternate Synods, etc., and others pertaining to the very continuance of congregations in the denomination must be given time and discussion. These need serious consideration which is not easily done online.
 - It is deeply troubling that we are electing again to meet in such a disconnected way to discern such issues that will affect the future of the Presbyterian Denomination in Canada.

We, as a Presbytery, are asking the Assembly Council to revisit and reverse the decision of Assembly Council to have an online GA this June 2022.

- 1. This reflects the dues which were not collected with the closure of St. James, Chatham
- 2. The Presbytery has \$300,000.00 invested with the Presbyterian Church in Canada and received interest payments twice yearly.
- 3. Paulin Church, Windsor continues to complete payments monthly to the Presbytery which would have previously gone to St. Andrew's, Windsor.
- 4. Dresden has advanced their payment of legal funds used to acquire legal possession of the Rutherford property. Remaining balance owing is \$7,125.36
- 5. The overexpenditure of clerk expenses resulted from the transition costs involved in change of clerks.
- 6. Leadership Roundtable continues to work as part of the Pastor Support Groups at Presbyterian College, Montreal. A quarterly payment was missed in 20221 and will be made in 2022.
- 7. The Bursary Fund has an approximately 42% share of the Presbytery Investments, so receive their appropriate share semi-annually.
- 8. This amount will be transferred to the General Fund in 2022.

Rev. Tim Reddish noted that Kathleen Knott accepted the commission with the understanding that the 2022 Assembly will be held online. Due to health issues, she would not be able to attend in-person.

Lakeshore St. Andrew's summer intern program.

LSA is seeking funds from three outside sources (presbytery, Synod and Canadian Ministries) to finance this summer ministry, which had to be cancelled in 2020 and 2021. Canadian Ministries is asking for presbytery's endorsement. Two documents (LSA student internship proposal, LSA student internship position description) provide details. Presbytery's Congregational Support Team (CST) previously recommended a one-time \$5,000 grant in 2020, which we anticipate will be presented to presbytery during today's meeting.

RECOMMENDATION 6 – That the Presbytery of Essex Kent endorse Lakeshore St. Andrew's student internship proposal and position description as the congregation seeks grants from Synod and Canadian Ministries funds.

- Pastoral care for presbyters. The clerk suggested that we establish a formal process of
 recognition for ministers and elders, including those on the appendix, who are

EMERGENT SUPPORT FUND

The fund was established in 2021 to address "emergencies when a congregation is seen to be in need of interim financial assistance" or "to support a Mission Plan in the community or beyond. This Mission Plan could be instituted by a congregation of the Presbytery or the Presbytery itself." Initial funds were to come from the sale of the former Hungarian congregation building. Approximately \$163,000 is expected to arrive from the national church office this month. Applications in writing must be made to Administration Committee. This fund will be administered by the Administration Committee on approval of the Presbytery.

St. Andrew's Dresden Gospel ads mission proposal. The Administration committee in November accepted this proposal in principle but because the ESF had no funds at that time, the session was asked to submit it to the Congregational Support Fund. This proposal was turned down by presbytery in November on the advice of the Congregational Support Team as it didn't meet its mandate. It now returns to presbytery for consideration under the ESF. The proposal from Dresden is for funds to cover weekly ads in the local newspaper and Coffee Times which have different scripture each week and lead people directly to the website and livestream link. It's frontline evangelism, designed to reach secular readers. Ads have been running since Advent. The committee acknowledges that this approach may not be effective in every setting, but St. Andrew's leadership is reporting that the ads have received some attention and some people in the community have asked church members what's going on there. The total estimated cost will be \$3,634 per year and session is asking ESF to provide \$2,700.

The Moderator stated the current Terms of Reference do not state requests are of a one-time nature but grants/loans will be consider on the merits of each application.

2. FOR INFORMATION

The Congregational Support Team (CST) in April 2020 recommended a \$5,000 grant to Lakeshore St. Andrew's towards its summer student intern program. However, presbytery never considered this due to its April meeting being cancelled and the program being put on hold for two years. LSA has requested that the CST present its recommendation to presbytery. If the CST is not willing to do that, then Admin Committee is proposing that this be considered under the Emergent Support Fund. As of writing, the status is undetermined. A recommendation will come if required.

WORKS IN PROGRESS

1. A convenor is needed for the Presbytery's Life and Mission Committee. Sandra Smith is in an acting capacity. The moderator approached an individual to consider this position. The position was declined.

2. Training of Elders for Baptism and Holy Communion

However, the reference to "catholic" and "apostolic" could be better explained (as done earlier with "prophet, priest, and sovereign"). We suggest as a friendly amendment adding to "catholic" (universal – the church in all times and places) and to "apostolic" (sent/commissioned by Jesus Christ).

Scot McKnight's The King Jesus Gospel: The Original Good News Revisited (Zondervan, 2016)

Although I had heard of Prof. Scot McKnight, I had never read one of his books. I found this one to be well worth the read. It starts with a "simple" question: "What is the gospel? People's responses vary - personal salvation, justification, atonement theories (e.g., penal substitution), etc. He cites one minister as saying that since Jesus didn't preach "justification by faith," Jesus couldn't have preached the "gospel" since Paul's understanding is post Jesus' resurrection and ascension! The point being that if the gospel is reduced to, say, "the four spiritual laws" or the "believer's prayer" then it has little to do Jesus' teaching, miracles, and his identity as Messiah.

Evangelicals (whose root Greek word *euangelion* means gospel – good news) have, in McKnight's opinion, effectively become "salvationists" (Greek *soteria*), hence *soterians*. The broader New Testament gospel culture has (mistakenly) become a salvation culture for many (evangelical) churches, especially in the US.

McKnight then points out that soterians have largely forgotten the Old Testament and focus on the New, particularly Paul's letters. For McKnight, the biblical picture has its *foundational sequence* of the story of $Israel^2 \rightarrow the$ story of $Israel^3 \rightarrow the$ plan of salvation $\rightarrow the$ method of persuasion⁴; for soterians, the order of importance is, in his view, reversed. The story of $Israel^3$ is first and foremost the resolution of $Israel^3$ story, and because of that, it $Israel^3$ the world. The "plan of salvation" is, then, not the same as "the gospel," (nor the "kingdom") but emerges from it. And the "method of persuasion" in many evangelical hands has, according to McKnight, "crushed the story of Israel."

McKnight then considers the apostolic gospel (Paul, Peter – what did *they preach?*) and the Jesus gospel – are they different?⁶ Starting with 1 Cor 15 – taken as an early creed – he shows how Paul

preached the Jesus story in the context of the story of Israel (as fulfilling "the scriptures"). Later on, McKnight supports his argument by detailed considerations the contents of Peter and Paul's sermons in the book of Acts.⁷ Since they preached what Jesus preached, there is then one New Testament gospel.

How then did modern evangelicalism lose sight of this gospel and become soterians? McKnight argues this did *not* arise in the church councils or creeds, nor in the Reformation, rather it emerged out of *Revivalism* and its personal and experiential focus.

McKnight's point is that evangelicalism, or some branches of it, have lost sight of the true gospel by only focusing personal decisions and disconnecting the New Testament message from Jesus *as Messiah*, a title that can only be understood in the context of the story of Israel – the *whole* biblical narrative. Some might think that this is a harsh critique. However, methods of persuasion that lead to personal decision-making does not necessarily lead on to discipleship.⁸ To help address that concern, I agree with McKnight that we need to appreciate *our identity as part of the ongoing biblical narrative*. Afterall, preaching Jesus as savior can be divorced from Jesus as

Messiah, Son of Man, Lord. And when we do that, we lose the rich meaning and theological significance of those titles.

I have often heard (at St. Andrew's) that the Old Testament should just be thrown away — it's superfluous, we want a (loving, kind, gracious) New Testament "God." Yet when I make connections with the Old Testament while preaching, people are fascinated and never realised the links. This book has caused me to no longer be shy or apologetic — not that I ever really was! — in using the Old to connect with the New, or to paint the big picture from creation to consummation. This book has also caused me to no longer be shy or apologetic in preaching from the Gospels, rather than imagine that is secondary to Paul's letter to the Romans! This book was straightforward to read, informative, has aspects that are "preach-able," and was encouraging. 10

Incidentally, I had previously read James Dunn's "Jesus, Paul, and the Gospels" (Eerdmans, 2011). He makes the exact same case of Paul and Jesus preaching the same gospel. It turns out Dunn was McKnight's PhD supervisor!

John Sanders' Embracing Prodigals: Overcoming Authoritative Religion by Embodying Jesus' Nurturing Grace (Cascade, 2020).

Prof. Sanders tells the well-known story of the prodigal son and then describes/defines "authoritative" and "permissive" fathers and compares them with "nurturant" behaviors. In the parable, the older brother is the one demonstrating authoritative values (moral judgement) and sees his father of behaving inappropriately, even immorally. The nurturant father is not permissive (i.e., anything goes) with the younger son, rather he lavishes forgiveness and acceptance to restore and transform their relationship. When we imagine God, do we see him as primarily as an authoritative rule-keeper or one who prioritizes forgiveness and relationship over rules? This book systematically presents a contrast between authoritative and nurturant values/behaviors¹¹ and connects them not just with parenting, but with God, Jesus, the Bible, theology, church leadership, psychology, politics, ethics, culture wars, etc.

The book is persuasive, accessible, well-researched and written, though a times a little long-winded. His primary audience is American, but his basic thesis – that Jesus (and hence, so is God,) was/is a nurturant – needs recognizing afresh in church cultures that favor authoritative Christianity (or God), and hence that leadership style, behavior, etc. Given the present polarization in American politics and Christianity, Sanders detailed portrayal of authoritative and nurturant values/behaviors is timely and eye-opening, perhaps particularly for an outsider trying to understand the confusing US cultural scene.

Having presented separate chapters on Jesus and God, he points out that our view of God shapes us. We are (in)formed by our predominant mental image of God, either authoritative or nurturant, and they have very different core values. And this impacts our relationships (marriages, parenting), mental health, decision making, and theology. That latter aspect is explored in a chapter on grace, which considers how our view of God influences, say, our view(s) of atonement, Holy Communion, and Baptism, non-Christians, and hell. Underlying all these is the different views on justice — and hence why "authoritatives" just don't "get" grace (the prodigal son story and other similar parables). Taking a step backwards, Sanders points out that these two contrasting views of God also shapes how we see and read the Bible itself. "Biblebelieving" Christians favor the authoritative view of God - and hence the ('inerrant') Bible - because it ties in with their quest for simplicity (clear boundaries, no nuance) and certainty (no

debate/ambiguities).¹³ This also shapes morality/moral behavior (i.e., ethics) and politics. The latter is made abundantly clear in his chapter on *religious* politics in America, as he (briefly) considers income inequality, race, health care, criminal justice, same gender marriage, democracy, and Trump. This book, then, presents a convincing framework to help understand America today. In short, our view of God (authoritative or nurturant) not only shapes who we are as individuals, but our family dynamics, church leadership, structures, and doctrinal tensions, and even national sociology. This is true whether one is a Christian or not.

Yes, I would recommend this book for its well-argued ecclesiastical and cultural commentary and its theological insights. While it is tempting to think his analysis oversimplifies things, he still makes his point convincingly. It also helps to understand the difficulty in meaningful theological dialogue between authoritatives and nurturants. In brief, the authoritatives don't really see the need to dialogue, after all, they know they are right. All that's needed is for you to recognize they are right; compromise or nuance is seen as watering down or the thin end to the wedge and hence inconceivable. For nurturants, dialogue is part of their values because relationship is more important than principles, faith/trust over certainty, situational ethics over rule keeping, grace over law.

The Congregational Support Team (CST) has received a funding request from Paulin Memorial for the technology needed to support the live streaming of the Sunday morning service to replace the present recorded version. This will greatly facilitate congregational engagement during the ongoing Covid restrictions. In addition, the request mentioned that this was part of a wider endeavour to make the most of new technology going forward, for instance in participating in the PCC New Beginnings program.

The Board has agreed that money from the Paulin Church Capital Fund will cover any remaining cost. While the intention had been to trial the live stream before Christmas, they dedicated to wait until they heard if Presbytery would provide financial support for the project.

CST DELIBERATION

The CST met via email communications between the 8-11th January, 2022 and determined that this request was similar, in principle, to previous on-line technology support requests already supported. We would have preferred more than one quote, but were assured by the Paulin Board that they had every confidence in the quote provided and would have chosen them anyway. In addition, the quote appeared quote reasonable to the CST.

PART TWO - FUNDING REQUEST FOR STUDENT INTERNSHIP PROGRAMME AT LAKESHORE ST. ANDREWS

Apparently this was never brought to Presbytery (the meeting in April 2020 was cancelled). This is on the understanding that this request is a one-off as we do not typically fund ongoing programmes.

CST Deliberation

The CST met via email communications between the Jan 30th and Feb 2nd 2022 and agreed to put forward the original (2020) motion to Presbytery, with revised dates to allow the funds requested to be applied to the current (2022) student internship request.

The CST approved a motion (Moved: Mike Maroney, Seconded: Wendy Skreptak) to bring the

following recommendation forward (Original motion with revised dates):

Recommendation #2:

That Presbytery grant the sum of \$5,000 from the Congregational Support Fund to Lakeshore St. Andrew's Presbyterian Church to assist in the implementation of their pilot project as outlined in the proposal to hire three summer interns from June 1, 2022, to August 30, 2022.

INTERIM MODERATOR REPORTS

Knox, Leamington - Rev. Lillian Wilton

Services at Knox continued in person for November and December with very competent supply preaching. The congregation was about 10 to 15 people at a service and they appreciated the preaching of those supplying. Finances held their own with about \$6000 to \$7000 above expenses. At the end of December the secretary/treasurer/organist/elder resigned and asked for their membership transfer as well as eight other people two of whom were elders. Session decided that because of the lack of an organist and because of Covid concerns services for the month of January would be via You Tube except for the service on Jan. 30 th 2022 which would be in-person before the annual meeting and Presbytery meeting to follow. The annual meeting at which twelve attended was held. A sum of two thousand dollars for Presbyterian Sharing was accepted as the allocation with the hope that the givings could be increased to three thousand if finances allow. There are a number of volunteers needed for leadership roles, the major one being a treasurer. To date all those with skills in this area who have been asked have declined. There are as well three committees who do not have any members or have only one person on them. A recommitment to Christ and his church is really needed.

At the Presbytery meeting Knox was encouraged to seek other ways to stay open and Session was given permission to contact other congregations in the Presbytery to see if any were interested in a partnership or other form of agreement to help Knox remain a visible witness in the downtown core. One proposal was

In 2021, The General Assembly received and adopted various recommendations contained in "Not All Are Welcome", the final report of the Rainbow Communion. "Not All Are Welcome" drew on the stories of people who shared their experiences of harm due to homophobia, hypocrisy, transphobia and heterosexism in the church. In recognition of the harm the church has caused, General Assembly decided that a fund should be established to provide financial assistance for accessing psychotherapy or counseling to support healing. These funds are available and the information about eligibility and how the fund is administered can be accessed at https://presbyterian.ca/2022/02/08/funding-for-harm-done.

TRUST DEED – PAULIN MEMORIAL
