#### BACKGROUND

In December 2021, St. Andrew's Dresden began publishing weekly ads in The Herald local newspaper and the Coffee Times. The content consisted of nothing more than a Bible verse, the name of the congregation and the website. The cost was shared by the congregation (approximately \$1,000) and a grant from the Presbytery of Essex Kent (\$2,700) from the Emergent Support Fund. As a condition of the grant, the session was asked to provide a report on the effectiveness of the ministry – see **IMPACT** below.

The idea is simple: publish key scripture verses regularly in non-church places in the prayerful hope that those who hunger and thirst for God will see and read and allow the words to settle into their hearts and minds. Here are samples:

We believe these ads need to continue in the current volume to maintain the impact. It's a fundamental rule of advertising to keep the ads going to maintain your presence in the market.

#### IMPACT

People are noticing the ads and they tell us they've seen them. And we strongly suspect that as a result, some readers are watching our live or recorded worship. Prior to COVID, we were getting 40-45 people in attendance. Now, we are getting 30-35 in person and an additional 15-30 views of our service on YouTube. No matter how you add it up, our numbers are higher and we suspect the ads are playing a significant role.

#### **FUNDING NEED**

The session of the congregation is eager to continue the ads. The 2023 estimated cost is \$3,828. A *Herald* ¼ page ad will cost \$150 + HST in 2023. Annual cost: \$2,034, tax in. *Coffee Times* is a weekly tri-fold newsletter distributed to restaurants –  $2.5 \times 2$  inches ad costs \$30 + \$4.50 HST per insertion = \$1,794 per year tax in. Total cost of ads: \$3,828.00

The Synod of Southwestern Ontario has granted \$1,000 towards this. We tried the national church (Canadian Ministries) for other sources for funding but this doesn't meet any criteria. We also applied to the Cooke's Fund (Presbytery of East Toronto). They require our application to be approved by our presbytery. They won't consider applications until sometime early in the new year.

The bottom line is that we have a funding shortfall of \$1,828. We could apply to the Cooke's Fund with presbytery's approval, but that's an unknown.

#### **REQUEST TO PRESBYTERY**

We are respectfully seeking a grant of \$1,828 from the Presbytery Emergent Support Fund. The request is made under item 2 in the fund's eligibility criteria: "To support a Mission Plan in the community or beyond." The Emergent Support Fund is not designed to be for one-time funding, unlike the presbytery's Congregation Support Fund.

At a meeting of session on October 4, 2022, the following motion was approved:

"That session of St. Andrew's Dresden requests funds from the Presbytery of Essex Kent for the 2023 Gospel Ad campaign."

Failing that, session requests that presbytery endorse its application to the Cooke's Fund.

Submitted for your prayerful consideration.

#### 2. General presbyter position – A. Cornell

Only two responses received to date. Clergy encouraged to respond. Shalini will resend the form.

#### 3. LSA special visitation –

Questionnaire was sent in early October and responses have been sent to the convenor. Sadly, one of the team members, Mike Currie, passed away unexpectedly in October. The convenor asked St. Andrew's Dresden clerk and rep elder Mark Labadie to join the visitation team to replace Mike Currie. Mark has kindly agreed to join the team.

# **RECOMMENDATION 6:** That Mark Labadie be named to the Visitation Team into LSA, in place of the late Mr. Mike Currie.

# 4. LSA Interim Moderator

Admin was given power to issue in the spring. Rev. Chris Little from Paris Presbytery has agreed to take this on as of Nov. 1. Paris clerk/mod reached out for a meeting with Essex-Kent mod and clerk to take place prior to Nov. 1. Handover tentatively Nov. 2 at LSA Session. There's also a question of whether the new interim mod should be appointed to the roll of Essex-Kent.

There's an additional question as to whether he should or can be appointed as an assessor presbyter. The clerk is looking into that in consultation with the clerks of Assembly.

FYI – The Clerk corresponded with Deputy Clerk Don Muir who advised Synod needs to make the appointment across presbytery boundaries. The following motion was adopted by the Executive of the Synod of Southwestern Ontario.

The Executive of the Synod of Southwestern Ontario appoints the Rev. Chris Little as an assessor elder the Presbytery of Essex-Kent and sustain his appointment as Interim Moderator to Lakeshore-St. Andrews Presbyterian Church as of Nov. 2, 2022, with his name added to the

#### Notes for the 2023 Presbytery Budget.

**Note 1:** The Synod dues include Knox, Learnington. Without that the amount would be \$19,652.20. The options I see for our presbytery are as follows:

A. Appeal the amount to Synod.

B. Pay the Synod dues minus the Knox amount.

C. Pay the Knox share out of monies being received from the sale of their assets.

D. Allocate the full amount among the remaining congregations. Some examples of the difference that would make are Amherstburg would go from \$887.77 to \$958.63, 1st Church Chatham would go from \$3220.20 to \$3473.76, New St. Andrew's would go from \$352.17 to \$378.50 and Lakeshore St. Andrews would go from \$8,694.26 to \$9,380.16

**Note 2:** We provided a one-year relief from full presbytery dues but this year will need to allocate the entire amount.

**Note 3:** For presbytery travel I recommend we pay \$.90 per kilometre one way instead of current \$1.

RECOMMENDATION 11: That the Treasurer's Report be adopted as presented. – Current balance – \$173,355.018. Moved by Cornell and Murdock. MOTION CARRIED.

RECOMMENDATION 12: That Learnington Synod Dues for 2023 be paid from the funds received from the sale of the building and that the 2024 dues be appealed. Moved by Sargent and Streptak. MOTION CARRIED.

#### Study Leave Report by Rev. M. Maroney

I spent my study leave at Crieff Hills Community, and read the book "A Curious Faith," by Lore Ferguson Wilbert. It would be fair to categorize this book as an exercise in spiritual guidance. It is, to put it simply, a book of questions that gently guides readers in an exploration of their understanding of God. The author admits that she has left behind some of her conservative church background with its inclination to see things in rigid and unflinching

categories. And yet, this is not an "anything goes" approach to God, but a sincere desire to understand God in the face of the ups and downs of life.

There are many reviews online for this book that will do a better job than I can, so I encourage you to read them should you consider buying this book. I started reading this book with some doubts. I thought it would be wishy-washy (the equally unpalatable opposite of the rigidness of some conservative thinking), but I found it spoke to me. In the middle of so much extremism, polarization, and name-calling in our world today, (of which I too easily do myself) it was a reminder that soft edges to life and faith abound, and that they are not devoid of God. On the contrary – it is in our vulnerability and openness that God can be found most visibly.

I also spent my time planning my message series through to June and walking the trails at Crieff Hills. The latter is usually an extended time of prayer, even if I am admiring the sunlight or the color of the leaves. I have gone to Crieff for study leaves for most of my ministry. In some ways there is no way to give a tangible report of what happens on my week away. I've come to understand it as a recalibration of heart, mind, and soul. These times away have helped me navigate the seasons of both joy and sorrow I have been through since my ordination in 2004. I am grateful for this time away, not just to rest, but to find God in the middle of my changing circumstances.

#### Study Leave report – Rev. Shalini Rajack-Sankarlal

Brian McLaren about "Do I Stay Christian?" Do I Stay Christian? Comes in three parts.

In these first chapters McLaren honestly addresses the way in which Christianity has been and is harmful to human beings, societies, and the world in which we dwell. These are things we need to confess if we are to move toward being authentically Christ-like.

For example, of the history of Christian anti-Semitism (chapter 1), colonialism (chapter 3), patriarchy (chapter 6).

From a North American point of view and specifically American he cites an anti-intellectual streak that rejects science and encourages poisonous politics; and an aging demographic that trends toward regressive views. Other arguments could be added, including traditional theistic theology which no longer rings true for a growing number of people in the twenty-first century.

In part two, McLaren lays out ten reasons for remaining Christian. In these chapters, McLaren seeks to carve out space for those who are inclined to remain a Christian, though never with a sense of triumphalism.

For example, he argues that leaving hurts the people who are trying to transform Christianity into something better, and they need our help, not our abandonment. And if we stay, we can fight for a better faith from the inside, providing critique and energy for reformation. Also, rather than going it alone, we need the help of a global network of like-minded people to make the world better. He also notes that Christianity is still young, historically speaking, and needs more time to mature and improve.

McLaren encourages us to stay Christian because of our love for Jesus and because all religions (like all humans) are imperfect.

My instinct is that most people struggling with faith will find part one (leave) more convincing than part two (stay). However, for those on the fence looking for more reasons to stay than to go, part two will prove helpful.

In Part 3, McLaren shifts to the third and final section of his book. He begins by asking, "Will we stay Christian? and Will Christianity survive? It has a humanist approach to it. **McLaren** calls for a radical redefinition of Christianity.

He says, "I could not stay a Christian if my only option was the old way, the old way of white Christianity, the old way of patriarchal Christianity, the old way of theo-Capitalistic Christianity; the old way of violent, exclusive, and authoritarian Christianity with its suppressed but real history of cruelty."

He notes things like "For most Christians I encounter today, beliefs are simply what Christianity is. If I point out that in its early years, Christianity was a way of life, not a set of beliefs, they will protest that it was both, and the beliefs had priority.

If I point out that the earliest Christians were widely divergent in their beliefs, they are surprised and doubtful; that's not what they have been taught." (p. 54)

While McLaren is certainly correct to note that Christianity was and is a way of life, he does fail to acknowledge that way of life has always been centered on a relationship that is framed in terms of *specific beliefs*.

He then moves to vintage "new kind of Christian" Brian McLaren fare. He says "I am learning to be content whatever I am called, as long as I remain passionately eager to embody a way of being human that is pro-justice, pro-kindness, and pro-humility. You have that permission too, if you would like it."

His closing words are, "A new humanity—humble, just and kind—can be born. Can you imagine that, fellow human?"

For so many people who are not looking for easy, black and white answers, with the just tell me what to believe perspective, this book will give them something to reflect on.

To strengthen the bonds between Presbytery and Congregations.

To re-establish a connection between the Presbytery and its congregations and, where necessary enact a healing process, {recognising that Presbytery has been absent for a long time except when there has been conflict or crisis}.

To identify and accommodate healing of conflicts where necessary.

To learn from one another and to share our congregational successes.

To celebrate positive events and ministry occurring in congregations.

To help identify congregational challenges, common and uncommon that are faced.

To help identify available resources to assist one another from all levels of our church, in addition to those outside our denomination.

To identify problems before they become a major crisis.

To help congregations identify their unique profile and culture and how it may enable or hinder their ministry.

# Visitation

- 1. Each Congregation will be visited at least once within a three-year period.
- 2. The first visit to a congregation will, where necessary, focus on reconnecting with Presbytery. We will confess our negligence in this task and seek forgiveness.
- 3. We assure congregations that we are there to be of assistance.
- 4. We will introduce Presbytery and its role to congregations that may be oblivious and/or indifferent, seeking to listen as to how Presbytery can better support the congregations in its bounds.
- 5. The first visit is a benchmark to set the scene as a snapshot, from which further visits can discern change.
- 6. Visitation Team will ensure they have spoken with the Minister and {if applicable and mutually agreeable} his/her spouse and family; Session and Board of Management; Staff; Congregation; Youth {where applicable}.

# **Visitation Team Composition and Process**

 Visitation Teams will be composed of members of presbytery and willing elders from Congregations within the Presbytery; three persons consisting of at least one Minister and one ruling elder and will not be from their own congregations. Efforts will be made to ensure teams express diversity along lines of gender, age and geographic location.

- 2. Ruling Ministers or Elders who are not Presbytery Representatives or who are on the "Appendix to the Roll" of Presbytery may be selected for this purpose.
- 3. The Life and Mission Committee will be responsible for maintaining a schedule of congregational visits each year, in addition to composition of the visitation teams.
- 4. Teams are responsible for contacting the congregation session to arrange the visit at a time that is mutually agreeable. Major Church events such as Advent, Lent, summer months and any other busy seasons need to be avoided.
- 5. The Visitation teams report will be submitted to the Minister and Session before being circulated to the presbytery through the Life and Mission Committee. Reports are to be submitted to Presbytery no later than the first meeting following the congregational visitation. i.e.) a visit occurs in June then the report is presented no later than the September Presbytery meeting; a visit in October, no later than the November meeting etc.

# **Visitation Content**

- 1. Visitations seek the general sense of the health of the congregation, its leadership, its pastor and the relationships of the three.
- 2. Visitations are pastoral in nature, inviting honesty, truth telling and seeking to celebrate successes, share empathy and where possible counsel, {keeping in mind that the team is not a counsellor} for their struggles. Their role is to provide recommendation to Presbytery and for Presbytery to offer counsel.
- 3. Visits will focus on the Ministry of Congregation in five key areas:
- a. Worship
- b. Discipleship
- c. Fellowship
- d. Service
- e. Evangelism
- 4. If necessary, the visitation highlights any concerns or potential issues that may impact the Congregation, so Presbytery may be aware in advance or propose aid.
- 5. A visitation team will also highlight the successes of a congregation and its efforts to impact the local community with the gospel of Christ.

#### Dear Clerk of Session,

Understanding your ministry will focus on key components, i.e.) worship, discipleship, fellowship, service and evangelism, in addition to any other components you may wish to include. This will help the visitation team to better understand the unique ways in which you have been called to the ministry work in your context.

Once the questionnaires have been distributed and collected, we request that they are returned to the convenor {name, address, email} and a copy of your annual report included if available. Following the visit, the Visitation Team will forward a report to the Life and Mission Committee for review and then forward the report to the Presbytery meeting closest to the date of the visitation. You will receive the report first to be allowed to comment before it is presented to the Presbytery.
