Report from M & D Committee

Call Documents for Sarah Stockford.

The committee read and discussed the *Call and Concurrence* documents for Sarah Stockford (*attached to the Docket and presented below*), and found them to be in good order, and no questions were raised concerning them.

Rev. Jim Young read the details of the Call document, including the stipend, and the Attestation of the Call.

Rev. Jim Young then read the following affirmation of Sarah Stockford by Lynn Murphy-Greer, Clerk of Session of Mansfield Presbyterian Church.

As outlined in the search process, on Saturday, September 14, 2024, an informal Meet and Greet was held at Knox Presbyterian Church from 2:00 to 4:00 pm, at which time members from both Knox and St. Andrew's were given the opportunity to meet Sarah and her boyfriend, Cameron. From the outset, it was apparent that Sarah (and Cameron) was very comfortable meeting new people. They stood together in the room in a spot that clearly indicated they were eager to make their personal introductions to individual members and exchange pleasantries. When meeting Sarah, you received a firm handshake, a pleasant smile, direct eye contact and she made it a point to get your complete name. She spoke very candidly about both her excitement and nervousness of potentially being the successful candidate for our dual charge, the prospect of moving to a smaller urban area and ministering to both a town and country church, and her keen desire to share her walk of faith with young and old, Members and Adherents and any and all newcomers to our respective parishes. After making herself available for formal introductions, Sarah circulated throughout the room, chatting and sharing a time of fellowship with all those in attendance.

The following day, September 15th, Sarah Preached for the Call at both St. Andrew's and Knox. Sarah conducted the Service with a sense of ease and confidence and a manner of delivery that belied her young age. She adhered to our usual order of service, which was so reassuring and appreciated by all those in attendance. Sarah's Sermon, which centered on the gospel of John 4, Jesus talks with a Samaritan Woman, was clear, concise and very thought provoking. She was able to stress through her message and the reading of a poem centered on Jesus' encounter with the woman at the well that in our everyday lives, Jesus brings us Salvation, He is not fazed by our sin, He is our Savior and we should all aim to serve him through our thoughts, words and deeds. When I reflected back on Sarah's sermon, it actually helped me Prepare my Reasons for Translation.

To begin, during conversations with Sarah it was apparent that her faith in Jesus Christ, the way she feels called to live her life in response to that as well as her compassion, commitment and confidence in difficult circumstances will enable her to become a valued leader in both congregations.

Sarah is a firm believer that her actions speak louder than words to demonstrate her walk of faith. I think this is a direct reflection of our beliefs at St. Andrew's. We are a small congregation, but we all wear many hats and are committed to our church and each other. We come together in times of joy, happiness and celebration but also support and uplift each other in times of tragedy, sorrow and unhappiness. We support community organizations such as the Local Food Bank and Elementary School Breakfast Programs. We own and maintain a beautiful cemetery. We all value our family, friends, neighbors and local community.

I feel that Sarah, too will value, support and nurture the pragmatic and spiritual health of our church community through her thoughts, words and deeds, her ability to convey sometimes difficult faith concepts in a relatable manner and her sense of calm and reassurance. Together with Sarah we can remain a vibrant, warm and welcoming country church.
