Admin Committee Matters – updates:

1. For Information - General Presbyter Position – The position was posted in the spring of 2024. There were a few expressions of interest, and one application was received but it was quickly withdrawn. In June 2024, Presbytery directed the committee to delve into the experiences of other presbyteries hiring similar positions. The Admin committee convenor sent inquiries to Calgary-MacLeod, Paris, Seaway-Glengarry/Ottawa (shared), Niagara, London, West Toronto and to the office of Ministry and Church Vocations (Marjorie Copeland, Tim Purvis). Here's a summary of the responses.

- Calgary-MacLeod appears to be "in about the same boat" as Essex-Kent according to clerk Sandra Cameron Evans. They had two people express interest in their current job posting but neither worked out. They refined the job description and will be reposting it soon no significant changes, more "a refocus of the role." Among the things Calgary-Macleod is dealing with is the challenge of attracting people West, especially for a part-time position. In their review, they couldn't see making it full-time not for lack of funds but not enough work. Their past two GPs were teaching elders (local retirees Peter Coutts and Jean Morris) but they are open to lay people, not that it's expanded their pool of candidates.
- Paris general presbyter position ended when incumbent Chris Little retired. The 10month position was created for that minister's unique gift sets, to offer pastoral care to clergy and guidance to congregations and sessions in regard to strategic and future planning.
- Niagara from Clerk Wally Hong: "Currently we do not have a GP. We have been planning for one since 2020. However, we have not advertised the position yet. We were slower in getting off the ground on forming a job description. We also became very busy with other matters. We will be reconsidering how to move forward this Fall."
- London from Clerk Carrie Thornton: "London still has a General Presbyter. The current contract will finish on Aug 31st and the current GP wasn't interested in renewing. The position description was circulated to the neighbouring presbyteries and posted on the PCC website. There was a tight deadline only three weeks and only one application was received. The applicant was interviewed by the search committee and ultimately accepted the position. Several people expressed interest after the deadline and their applications weren't considered. Both times the GP has been a minister on the appendix but the other interested applicants in both 2021 and 2024 were from outside the Presbytery of London."

Ottawa/Seaway-Glengarry – From Ottawa clerk James Hurd and S-G clerk Donna McAlveen: the two presbyteries employ a half-time "Presbytery Ministry Animator" (PMA) which in Ottawa is to foster youth ministry, supporting youth leaders in congregations and arranging presbytery-wide youth activities, and, in Seaway-Glengarry, to provide educational support and events for lay leaders, including training for elders. The PMA also works as Family Ministry Coordinator for Knox Manotick. (He is a graduate of Tyndale with both a B. A. in Religious Studies and an M. Div., former youth pastor in a Baptist church in Flushing, New York.) It was advertised locally in the two presbyteries of Ottawa and Seaway-Glengarry, nationally on the PCC website, and with an ad in the Presbyterian Connection newspaper. The search process took a few months which included establishing a job description, obtaining presbyteries. The applications received by the search committee were from people who live within the bounds of the presbyteries.

Based on this feedback, the convenor offered the following thoughts:

- a. Amend the job description to allow non-ministers to apply. The downside is that it would no longer be a presbyter/minister peer who could counsel/support existing clergy, which seemed to be the primary responsibility. I'm intrigued by the Ottawa-area position which is focused on lay training/youth.
- b. See if London or Lambton-West Middlesex presbyteries want to partner with us and make it a full-time call?
- c. Presbyteries seem to call retirees from their midst; shall we consider approaching some of those on our appendix personally?

The committee discussed the matter. Upon reflection, the Essex Kent job description may come across as too "austere." Additionally, it feels like the court is dumping onto the GP the things we don't want to do. We wondered if it could be amended to invite creativity.

For information: Revs. Shalini Rajack-Sankarlal and Tim Reddish offered to bring an amended job description to a future committee meeting.

2. For Information - Dresden/Rutherford amalgamation (2015) update. The plan is finally in the midst of completion. Session recently approved the hiring of a listing agent for the Prescott Farm. In consultation with the Clerks of Assembly, we are finalizing a trust agreement that will protect and guide disbursement of the net proceeds. Rather than a traditional trust, at the suggestion of the Clerks (and approval of our legal counsel) we are establishing a "designated fund" which will be managed by Session. Our prayer is that the trust will provide financial viability for the congregation for many years. *Of note, item 13 of the Amalgamation Plan states that five-per*-

cent of the funds received from the sale of the farm will be directed to presbytery's Congregational Support Fund. (The delay in completing the plan was due to two factors: successful transfer of title to the property to the congregation and the completion of the current five-year lease with a local farmer.)

Administrative Committee New Business:

1. Representative elders – We are aware that congregations are sometimes challenged to find elders to fill this role. We discussed some possible solutions. Rev. Shalini Rajack-Sankarlal volunteered to consult with the Clerks of Assembly and at the possibility of appointing more than one rep elder per congregation. Don Muir and Victor Kim determined that while the Book of Forms says the session will appoint one of its members, they do not see it as necessarily being the *same* person (BoF 114.7). However, with more than one person representing the congregation, they wanted to *ensure we knew this meant each congregation only had one vote*. They also expressed a concern about the effectiveness of decision making and continuity if the rep elder changed every month, but then conceded that reading the minutes and other communication would lessen that.

MOTION: That Sessions be invited to appoint more than one representative elder to serve on a rotating or alternating basis with the understanding that each congregation has only one elder representative vote.

MOVED by Cornell and Rajack-Sankarlal. MOTION CARRIED.

2. Presbytery Committee membership.

MOTION: That Rev. Brian McGuffin be added to Life & Mission and Rev. Shirley Carleton be added to M&D.

MOVED by Cornell and Rajack-Sankarlal. MOTION CARRIED.

3. First Presbyterian Church Chatham is seeking permission to begin the search process,

MOTION: That the congregation be allowed to begin the search process. MOVED by Cornell and Rajack-Sankarlal. MOTION CARRIED.

At this point the meeting paused for dinner with the blessing being given by the Moderator.

The meeting continued at 7:25pm.

4. Sarah Stockford's Call to the two-point charge of Knox Alliston and St Andrew's Mansfield in the Presbytery of Barrie was announced, and Rev. Cornell expressed Presbytery's congratulations to Sarah.

Rev. Jim Young, their Interim Moderator, reported (via email) that Sarah conducted the two Worship Services on the 15th of September, and they were *very* well received by both Congregations. With almost all of the votes on the Call now totalled, the vote represents an approval of the Call by 95% of both Congregations.

They have agreed to a Stipend of \$49,181.00 which is the 3rd level on the 2025 scale from the A & P. Her two-point charge travel allowance is \$4000.00 as against the A & P allowance of \$1800.00. Her Education Allowance, Accommodation, Utilities, Health and Dental, CPP and EI have all been included. Our biggest challenge will be finding the accommodation she has requested as the Housing Market in Alliston is in a ridiculous state though you could argue it's just like the rest of our Country. Sarah did look at a house when she was here on the weekend and was pleased with it. We are still negotiating as the landlord would like us to pay the whole year's rent in advance. While this is not a financial impossibility for the congregations it seems more than a little ridiculous.

In short, Sarah's package is at present valued at \$98,000.00 with permission from the Sessions and Boards in place to exceed that by a few thousand dollars if need be for housing or utilities costs.

It is hoped that Sarah can begin her new charge by the 1^{st} of November and be formally inducted on the 3^{rd} of November.

We note that their presbytery meets on Oct 8 to, among other things, process the Call. The Clerk has been assured that we will receive an electronic copy by Oct 10. This will then be forwarded to M & D to assess before having *a Special Meeting of Presbytery via Zoom* to process the Call.

MOTION: That we hold a Special Meeting of Presbytery *via Zoom* to process Sarah's Call no sooner than October 15. (Date, time, Zoom link to follow.) MOVED by Cornell and Rajack-Sankarlal. MOTION CARRIED.

Having made consultations, we propose that Sarah Stockford's Ordination Service take place at Paulin Memorial Church, on Oct 27th at 2:30pm (with Presbytery meeting first at 2pm) and followed by refreshments.

MOTION: That we hold a Special Meeting of Presbytery at Paulin Memorial Church on Oct 27th at 2:30pm, with Presbytery meeting first at 2pm, to ordain Sarah Stockford. MOVED by Cornell and Rajack-Sankarlal. MOTION CARRIED.

The committee met on September 12, 2024, and after much discussion would recommend the following motions:

MOTION 1: That oversight of regular presbytery financial matters other than special funds remain the responsibility of the Administration committee.

MOVED by Congram and Rajack-Sankarlal. MOTION CARRIED.

MOTION 2: That the Congregational Support, Duart, and Emergent funds be merged into a single fund and oversight of which this committee will be given responsibility.

MOVED by Congram and Rajack-Sankarlal. MOTION CARRIED. It was however recognised that Presbytery would need to consider the necessary changes to the above three funds' Standing Orders at a future meeting. Until that those changes are approved, the current guidelines remain in place.

MOTION 3: That oversight of the bursary fund be given to the Ministry and Doctrine Committee since they are the ones usually tasked with matters such as oversight of ministry students and request for study leaves.

MOVED by Congram and Rajack-Sankarlal. MOTION CARRIED.

MOTION 4: That this committee be renamed "*Ministry Grants*" with a two-pronged focus including facilitating current ministry initiatives as well as visionary new initiatives. The committee will assume responsibility for developing a mandate for this work as well as necessary changes to the standing orders both of which will require presbytery approval.

MOVED by Congram and Rajack-Sankarlal. MOTION CARRIED

Grant Requests.

Recommendation 1: That the request for \$2500 from First Presbyterian Church, Chatham regarding training for their people involved in their Saturday breakfast ministry be approved. This training is intended to help prepare their breakfast team members in coping with individuals suffering from mental health and related crises who may attend. The committee noted the commitment already invested by First Church and the increasing urgency of such training, and so made an exception in recommending full funding of the relatively small funds requested. **MOVED by Congram and Rajack-Sankarlal. MOTION CARRIED**

Recommendation 2: That the request for Accessible Original Worship Music Resource from Lakeshore St. Andrew's be given \$4000. This initiative is designed to write, arrange and record new worship songs that are simple to sing and play and will be made available to other churches. Recipients of this grant will be asked to provide a report on the ongoing development of the project and specific details about how the money was spent.

Drawing on the early church's theological giants—Origen, Augustine, Gregory the Great, and more from the historical cloud of witnesses—author Jason Byassee models how we can recover ancient Christians' multiple ways of reading the Bible to our benefit. As Byassee says, God himself is Jewish, Catholic, and Pentecostal—so much larger than our own little corner on the truth—and this book offers readers a refreshingly enhanced vision of the Bible and of Jesus himself."
